No.F.3(4)/Lit./02 In exercise of the powers conferred by clause (b) of the sub-section (2) of Section 3 of the Oaths Act, 1969 (No.XLIV of 1969) read with the Government of India, Ministry of Home Affairs' Notification No.U-11030/2/80-UTL dated the 14th October, 1980, the Lt. Governor of the National Capital Territory of Delhi, hereby appoints, till further orders, the following person as Oath Commissioner in the National Capital Territory of Delhi, for administering Oaths and affirmation of affidavits to be used in proceedings other than judicial proceedings and before the authorities other than the court of Law :-

- (i) The Oath Commissioner shall follow, as far as may be practical, the procedure laid down in the High Court Rules and Orders and instructions issued by the High Court of Delhi from time to time to Oath Commissioners appointed by the Delhi High Court or instructions issued by this Government from time to time.
- (ii) The Oath Commissioners shall not be charged fee exceeding Rs.5/- per affidavit.
- (iii) The Oath Commissioner shall use rubber stamp of different shape other than the one being used by the Oath Commissioners appointed by the High Court of Delhi and the stamp shall bear the words "Oath Commissioner appointed by the Govt. of National Capital Territory of Delhi".
