NOTICE FOR MEDIATION CAMP

The Delhi Government intends to hold a Mediation Camp in October 2010, for resolution of cheque-bounce cases (under Section-138 of NI Act) and consumer related cases, whether pending in Courts / Consumer Forums or pre-litigative.

The mediation shall be conducted by trained mediators at Delhi Government Mediation Centers. Those parties interested in resolving their disputes through mediation may approach DDRS at its Registered Office or any of the Mediation Centers mentioned below, along with relevant particulars so that the notices may be sent to opposite parties. Complaints may be sent on plain paper or on email address giving details of names with addresses and phone numbers of parties, brief facts of dispute and if the case is pending, then name of the Court.
