PROCEDURE FOR SUBMISSION:

The eligible companies/corporations shall submit their technical and financial bids on Delhi Government e-procurement portal i.e. https://govtprocurement.delhi.gov.in/nicgep/app

The tender document is also available on the website of this department at https://law.delhi.gov.in

No manual submission of the same shall be entertained.

Scanned copies duly signed and stamped of the following documents must be uploaded with the bids.

- A. Duly completed Covering Letter as per Annexure-I, printed on the official letter head of the bidder.
- B. Technical Bid as per Annexure-II, Annexure-III and the terms and conditions duly signed.
- C. Relevant supporting documents for the Technical Bid, if any.
- D. Financial Bid as per Annexure- IV.
- E. Scanned copy of EMD/Bid Security
- F. Copy of Authority letter issued by the Insurance Company in favour of the signatory of tender document.
- G. Copy of documents mentioned at (A) to (F) in following terms and conditions.

TERMS AND CONDITIONS:

- 1. The companies/ corporations should have a valid and subsisting license for providing Group Term Insurance from the appropriate government authorities e.g. IRDAI etc.
- 2. The companies/ corporations should have a net reserve equivalent of at least 50% of the Term Life coverage for which the tenders are invited.
- 3. The companies/corporations should not have been blacklisted by any government organization in the last 10 years.
- 4. The companies/corporations should have experience of handling at least 3 group-term insurance policies, each covering 10000 beneficiaries or more for a minimum period of 2 years.
- 5. Term Life coverage of INR 10 Lakhs per member must be provided for all the eligible advocates below 75 years of age enrolled with the Bar Council of Delhi and who are also registered in voters' list of Delhi.
- 6. The companies/ corporations shall submit bid for the basic premium rate and GST, if applicable, and other applicable taxes in prescribed format as contained in ANNEXURE-IV.
- 7. Only one authorized representative of the bidder may be present at the time of opening the tender.
- 8. Financial bids of technically qualified parties shall be opened at a subsequently notified later date.
- 9. The Technical Evaluation Committee/standing committee constituted by the Government of NCT of Delhi shall assess the

eligibility of the companies/corporations to render the requisite services based on the company profile, rating and on such other criteria as it may fix and furthermore, the Financial Bids of only those companies/corporations qualifying the technical evaluation shall be considered.

- 10. Bids which are late / vague/conditional/incomplete /not conforming to the procedure laid down hereunder, in any respect whatsoever, will be rejected.
- 11. Bids sent by fax & e-mail will not be accepted.
- 12. The bidder must sign on each page of all the bid documents.
- 13. In case of any dispute arising from the interpretation of the terms and conditions of the tender documents, the decision of the Government of NCT of Delhi shall prevail as final and binding on all concerned.
- 14. The scheme proposed by the bidder must have provisions for new enrollment of eligible advocates on pro-rata basis during the term of policy.
- 15. Age of eligible advocate must be below 75 years on the day of awarding contract to L-I bidder.
- 16. Reports including the claims of individuals and the details of settlement are to be furnished on a monthly basis to the BAR COUNCIL OF DELHI or as and when required by the GNCTD.
- 17. The successful bidder shall, at its own cost, comply with all the provisions, orders and notifications as may be issued by the IRDAI, the Government and the competent authorities from time to time.
- 18. The settlement of claims shall be strictly in accordance with the provisions of the Insurance Regulatory and Development Authority of India (Production of Policy Holders Interest) Regulations, 2017 as amended upto date or any other notifications/guidelines/regulations/rules etc. that may be made in this regard.
- 19. The Courts of New Delhi alone shall have the exclusive jurisdiction to try any matter, dispute or reference arising out of this service between the bidders and the Government of NCT of Delhi.
- 20. The period of contract will initially be for one year and the same may be extended further on yearly basis by the competent authority of Govt. of NCT of Delhi on mutually agreed existing terms and conditions. Furthermore, the Contract is liable to be terminated with one month's notice, if any lapse or unsatisfactory performance of the company is noticed.
- 21. The Government of NCT of Delhi reserves the right to modify/change/delete/add any further terms and conditions prior to issuing the contract. Further the Government of NCT of Delhi also reserves the right to cancel/withdraw the tender at any stage of tender process without assigning any reasons.
- 22. A.D.R.: All disputes shall be initially referred to mediation through a mediator appointed by Delhi Dispute Resolution Society. In case the parties are unable to amicably settled their dispute(s) through mediation then the dispute/differences shall be referred to an Arbitrator appointed by the Delhi International Arbitration Centre, whose decision shall be final and binding on all concerned parties.

- 23. The bidders shall deposit earnest money of **Rs. 32,00,000/-(Rupees Thirty Two Lakh only)** in the form of Account Payee Demand Draft/Fixed Deposit Receipt/Banker's Cheque or Bank Guarantee from any of the Commercial Banks in favour of Principal Secretary, Department of Law, Justice & Legislative Affairs, Government of NCT of Delhi. EMD/Bid Security should be valid for a period of forty five days beyond the final bid validity period. Companies seeking exemption are required to submit the copy of such relevant Government notification issued in their favour for such exemption.
- 24. The successful bidder shall also deposit Performance Security for an amount of Five per cent (5%) of the value of the contract as specified in the bid documents in the form of Account Payee Demand Draft/Fixed Deposit Receipt/Banker's Cheque or Bank Guarantee from any of the Commercial Banks in favour of Principal Secretary, Department of Law, Justice & Legislative Affairs, Government of NCT of Delhi. Performance security should remain valid for a period of sixty days beyond the date of completion of all the contractual obligations of the successful bidder. Companies seeking exemption are required to submit the copy of such relevant Government notification issued in their favour for such exemption.
- 25. In addition to the submission of scanned copy of EMD/bid security, original physical copy of EMD/Bid security is required to be submitted in the tender box kept in room no. C-812 at 8th Level, C-Wing, Delhi Secretariat of Department of Law, Justice & L. A., Government of NCT of Delhi. Last date of Submission of physical copy of EMD is up to 11/10/2024 6:00 PM. Companies seeking exemption are required to submit the copy of such relevant Government notification issued in their favour for such exemption.

The Companies/Corporations shall also be required to furnish the copies of following documents in addition to the documents asked for in the tender document:

- a) IRDAI Accreditation Certificate.
- b) Details of the Government/Semi-Government/Government of India Undertaking/ Autonomous Body or Private Body for which such Insurance Scheme has previously been provided covering at least 10000 beneficiaries or more for a minimum period of 2 years, along with proof thereof.
- c) Declaration asseverating that the company has a net reserve equivalent to at least 50% of the term life coverage for which the tenders are invited, along with proof thereof,
- d) Affidavit/Declaration declaring that the company has not been blacklisted by any government organization in the last 10 years.
- e) A dummy copy of the Group Term Insurance policy as applicable with detailed terms and conditions.
- f) The turn over certificate or Balance Sheets of the company/corporation for the financial years 2022-23 and 2023-24 relating to insurance business of the company.
